The Applicant is requesting to vary Section 52(6)(f) of Zoning Bylaw 1997, No. 2950 at 4065 Sahtlam Road legally described as the West 40 Acres of Section 1, Range 1, Somenos District, Except Those Parts Included within the Boundaries of Plans 4149, 4186, 4802 and 605 RW (PID: 003-489-736).

## **Purpose of Variance**

The purpose of the variance is to reduce the minimum permitted side-yard setback from 30 metres to 9.5 metres to allow for an existing accessory building to operate as a Dog Kennel on the subject property.

A copy of this notice will be delivered to all owners and occupants within a 60-metre radius of the subject property as shown on the map.

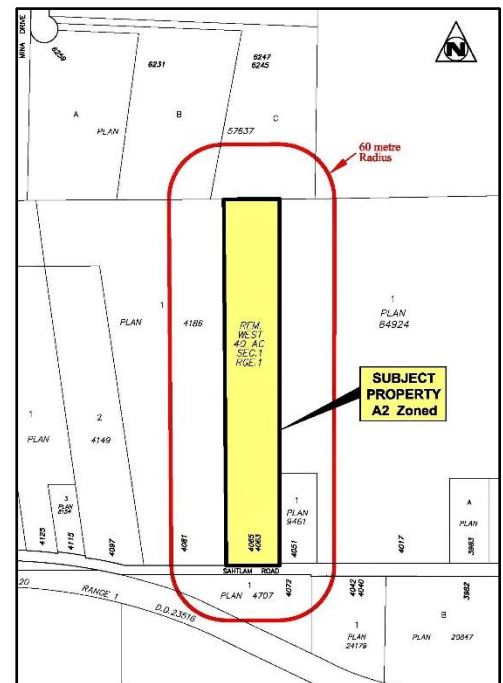
