- b) I am 18 years of age or older today, **OR** if an election or assent voting is in progress, I will be 18 years of age or older on general voting day for the election or assent voting;
- c) I have been a resident of British Columbia for at least 6 months immediately before today;
- d) I have been a registered owner of real property in North Cowichan for at least 30 days immediately before today;
- e) The only persons who are registered owners of the real property identified in (d) above are individuals who are not holding the property in trust for a corporation or any other trust;
- f) I am not entitled to register as a resident elector in North Cowichan;
- g) I have not registered as a non-resident property elector in relation to any other parcel of real property in North Cowichan; and
- h) I am not disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and am not otherwise disqualified by law.

READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE APPLICATION FORM

- (1) Print applicant's surname and given names in full.
- (2) Print applicant's residential address, including street number and name, city/town and postal code.
- (3) Print mailing address if different from the residential address.
- (4) Print *either* the last 6 digits of the applicant's social insurance number *or* the applicant's birthdate. This information is required pursuant to the *Local Government Act*.
- (5) Complete this section if the applicant's name has changed since previously registering as a resident elector.
- (6) Applicant must declare that he or she meets all the requirements listed in this section to register as a resident elector.
- (7) Applicant must sign the application form in the presence of a witness.
- (8) The witness to the applicant's signature must sign the application form.
- (9) Print residential address of the witness. Not required if the witness is an election official.
- (10) You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering under this section indicates that there is more than one individual who is the registered owner of the real property. The person may only register as a non-resident property elector with the written consent of the number of those individuals who, together with the person registering, are a majority of those individuals.
- (11) If person is registering at the time of voting, 2 pieces of identification (at least one with a signature) to prove identity are required.
