Zoning Amendment Bylaw

Bylaw No. 3958

A bylaw to amend Zoning Amendment Bylaw 1997, No. 2950 to update the regulations regarding on-site location for garbage containers and enclosures.

The Council of The Corporation of The District of North Cowichan, enacts in open meeting assembled, as follows:

Citation

1 This Bylaw may be cited as "Zoning Amendment Bylaw No. 3958, 2024".

Amendment

2 Part 4 of Zoning Bylaw 1997, No. 2950, is hereby amended by striking out Section 29 [On Site Location for Garbage Container] and inserting the following in its place:

"On-site Garbage, Recycling and Composting Containers and Enclosures

- (29) (1) All lots developed for multiple-family residential, commercial, or institutional uses must provide a common area(s) for a garbage, recycling and composting containers that meet all the following:
 - (a) Enclosed by walls or decorative fencing for the purposes of screening; and
 - (b) At a convenient location and elevation; and
 - (c) On the same lot as the use for which it is required.
 - (2) Subsection (1) does not apply to townhouse developments."
- Part 5 [*Zones, Division (2)*] of Zoning Bylaw 1997, No. 2950, is hereby amended by deleting the following subsections:
